## MEMBERS DECLARATION

Please read the following carefully before signing the Declaration:

1. The City Rifle Club is an approved Home Office Club. To comply with their requirements we must obtain a declaration from each applicant about status, safety and security.
2. Firearms Certificate holders must give details of their certificate.
3. Applicants who do not hold a Firearms certificate must declare that they have not been prohibited from possessing a firearm or ammunition under Section 21 of the Firearms Act 1968 (as amended).
4. Section 21 of the Firearms Act 1968 applies to anyone who has been sentenced to imprisonment, youth custody or detention in Youth Offenders Institution for 3 months or more but less than 3 years, the prohibition lasts for 5 years from the release date.

*It is an offence for anyone to give or lend a firearm or ammunition, including club equipment to anyone prohibited under section 21.*

- I am **NOT** prohibited under Section 21 of the Firearms Act 1968 (as amended).
- I have **NEVER** had an application for a Firearms Certificate refused by the Police, nor a Firearms Certificate revoked.
